David Ewing is a ninth generation Nashvillian and a lawyer with the law firm of Rudy, Wood & Winstead.

David has researched the Dutchman's Curve train wreck and interviewed several Nashvillians about the crash and aftermath. He is an avid historian and collector of Nashville history.

David has previously served on the boards of Cheekwood, The Hermitage, Travelers Rest, The Metro Historical Commission and Metro Historic Zoning Commission. He is currently President of The Old Oak Club and Chairman of The Board of Zoning Appeals. He also serves on the advisory board of Montgomery Bell Academy, the alumni board of Connecticut College and is on the board of Friends of Warner Park and The Nashville Symphony.

David is a graduate of University School of Nashville, Connecticut College and Vanderbilt School of Law.

In 2004 Nashville Post Magazine named David as one of Nashville's "25 Most Influential African Americans" and was on The Tennessean's Top 40 Under 40 list.
