**Chief Justice Janice Holder
Tennessee Supreme Court**

Justice Holder, a twelve year member of the court, was sworn in as Chief Justice on September 2, 2008, making her Tennessee's first female Chief Justice.

Before being appointed to the court, she served as a circuit court judge for the Thirtieth Judicial District, Shelby County, Tenn.

Holder was appointed in 1996 to the state Supreme Court by Gov. Don Sundquist and was elected in a yes/no retention vote in 1998. She was then re-elected to a full eight-year term in 2006.

Exchange Club of Nashville's Payment Policy

SECTION 27 of the Club Bylaws reads as follows:

INITIATION FEES, DUES, AND ACCOUNTS.

There shall be an initiation fee fixed by the Board of Directors for new members which must be paid in cash prior to the first meeting which he or she attends. Quarterly dues shall be payable in advance on the first day of each quarter (July, October, January and April) at the rate fixed by the Board of Directors. All accounts other than dues are payable on the first day of the following month. The Treasurer shall be furnished a list of all accounts delinquent for 60 days, and he or she shall use reasonable and appropriate means for collecting same. Any member who is delinquent in the payment of dues or other accounts as much as 90 days from the due date may be suspended from the Club by the Board of Directors, such suspension may be removed by payments by the member of his or her entire past due account within the next 30 days after he or she has been placed upon the suspension list, and in the event such payment is not made as required by the Board of Directors, the member shall be dropped from the membership roll of the Club.
