NCN helps entrepreneurs with business ventures that have the potential to attract institutional equity refine their business concepts, prepare for the fundraising process, and raise equity capital. NCN has cultivated a complementary network of qualified and committed Angel investors. NCN deals on Chambless' watch include Continuum, MyOutdoorTV.com, Spirit Broadband, TrackPoint Systems, Tricycle, Protein Discovery, The Documentary Channel, Capital Confirmation, Plumgood Food, Smartvue Corporation, Enliven Partnership, Pathfinder Therapeutics, and Horizon Resource Group. Additionally, Chambless serves as the Managing Partner of NCN Angel Fund I, LP, NCN's complementary \$5.2 million sidecar investment fund. Chambless is a 2003 graduate of Vanderbilt's Owen Graduate School of Management, where his concentration was finance and accounting with an emphasis in entrepreneurship. Prior to his MBA education, he was Executive Vice President of Surfari, Inc., responsible for mergers and acquisitions, capital-raising, business development, and sales and marketing activities. In November 2000, he co-directed the sale of Surfari to Chicago-based Coolsavings.com (NASDAQ: CSAV). Earlier, as part of the Nashville Predators' original staff, Chambless helped the Predators reach the NHL-mandated 12,000 season-ticket mark. Chambless is a member of The Tomorrow Fund, a Nashville group of young professionals dedicated to building community awareness, leadership and responsibility.

A native of Albany, Georgia, Chambless is a 1996 graduate of Vanderbilt University.
