Vanderbilt University**

Seven seasons into his stay in Nashville, Stallings has put into place a strong base with five postseason appearances, an NCAA Tournament Sweet 16 in 2004 and a pair of 20- win seasons.

In fact, over the past 28 seasons, success has followed Stallings throughout his basketball career as a player at Purdue, an assistant at both Purdue and Kansas and his previous head position at Illinois State. During this time span Stallings has been a part of 19 seasons with 20-or-more victories. Twenty-three times a campaign has concluded during postseason play. Since coming to Vanderbilt in April 1999, Stallings has compiled a 122-96 record while moving his 13-year overall coaching mark to 245-159.
