Why he gives back: "I have an obligation to give back to the community that I love. I feel so blessed to have what's in my life. I believe in sharing."

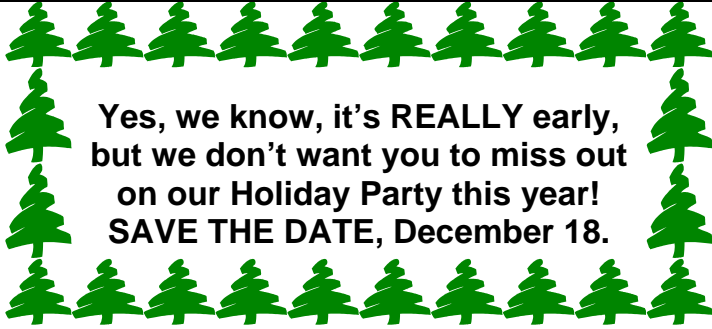
New Member Education Dinner Has Been Rescheduled
